RC/ML includes two elementary schools, a high school, Heritage Center, and six parishes on Pine Ridge Indian Reservation in SW South Dakota. By integrating both Lakota culture and heritage with spiritual beliefs from the Lakota and Catholic traditions, RC/ML aims to educate both the mind and the heart of its students, creating leaders of tomorrow with competence, conscience, and compassion.

## **Farm to School Summary:**

The Red Cloud Food Sovereignty (FS) Student Intern will be responsible for completing daily farm tasks (including but not limited to weeding, watering, planting, harvesting, and pest management), maintaining spaces to ensure functionality and longevity as well as to create a welcoming and safe environment for youth and other visitors, and provide support for the educational programming offered by the farm to school initiative. FS Interns will work with the Lakota Cultural Foods Coordinator to gather and preserve medicines for use during the school year. Must be willing to work outside in various weather conditions. The FS Student Intern should also be willing to assist activities with youth during summer school. The FS Student Intern may also be asked to attend meetings, training, or workshops related to horticulture, education, or food sovereignty. Previous experience is not required as training will be provided on the job. An interest or passion in food sovereignty and food systems is preferred. Interns will also work with the Lakota Language Camp as assigned.

#### I. DUTIES AND RESPONSIBILITIES:

#### A. Curricular Support

1. Support student activities at the school farm and assist with student activities during summer school 2. Offer creative ideas and suggestions for curriculum development

## **B.** Building and Grounds

- 1. Daily Responsibilities: Water Plants, Feed Fish and Chickens
- 2. Planting and Weeding the garden and the greenhouse.
- 3. Regular Pest Management in greenhouse and garden (under supervision of coordinator) 4. Harvesting and processing of the produce
- 5. Support the construction of the new chicken coop

## **C. Grant Compliance**

- 1. Must follow time-keeping procedures set forth during internship orientation
- 2. Must use work time to fulfill grant obligations, completing tasks as assigned each day
